# The Downtown Presbyterian Church Session Meeting Minutes - October 16th, 2023

A meeting of the Session of The Downtown Presbyterian Church was held at the residence of John Booth on October 16th, 2023 beginning at 4:30 p.m.

Mr. Harris led an opening prayer. Rev. Berry called the meeting to order at 4:36 p.m.

#### Approval of the Agenda:

Following a brief introduction, Matt and Amanda Abfalter shared information about their individual faith backgrounds and interest in joining The Downtown Presbyterian Church. Matt was baptized at DPC in 2018, and was presumed to be a member, but unfortunately, did not meet with the Session at that time to proceed officially with the membership process.

The Session expressed their joy in welcoming both Matt and Amanda into the full membership of DPC, acknowledging they have been considered members for quite some time. The Session expressed gratitude for the many ways that both Matt and Amanda enrich the DPC community through their presence and commitment to church ministries and missions.
